GUIDELINES

(The following guidelines and policies are provided to ensure fairness to all participating artists and to the buying public.)

Artwork for jurying and inclusion in the show must be original. Assistance of commercial molds and kits may not be used. Resale of purchased items is forbidden.

Framed or unframed machine or photomechanical reproductions of original work may be displayed on panels in booth space. Prints must be clearly identified. No more than 1/3 of display area (wall space) may be devoted to prints, bins excluded. All work must be for sale.

No machine or photomechanical reproductions of original work on clothing or cloth bags will be accepted.

Artists should only exhibit and sell work typified by their juried material. The Arts in Central Park Committee will screen booths during the weekend. If work is not consistent or rules have not been followed, artists may be asked to leave. The committee's judgement is final. No refunds will be given.

Tables used in the booth should be covered and draped to the ground. All storage boxes should be neatly stacked and/or covered behind booth.

Artists must be present both days. No agents allowed.

Artists should plan to exhibit rain or shine.

No refunds for cancellations will be given.

Artists are encouraged to exhibit during the Artists/Patrons Preview Party on Friday evening 9.14.18 from 5-7. It is a great opportunity for early sales.

Pets are not allowed in Central Park.

- a beautiful location in the newly redesigned and renovated Central Park in downtown Decatur with its historic Transfer House and magnificent fountain
- kids arts activities and an art shop for kids
- VIP program with guaranteed patron purchases
- live entertainment
- food vendors

You are invited to submit an application to join other artists for this wonderful summer tradition. All media fine art and fine crafts are eligible for jury.

For the artists:

- hospitality room
- light dinner during the Friday evening Artists/Patron Preview Party
- assistance available for set-up and take-down
- booth sitters for breaks each day
- monetary awards

SPACES

One 10'x10' space is provided for each artist. Spaces vary in clearance height due to trees. If you use a canopy, please indicate height on the application so the committee can assign you a suitable location. Special requests will be considered when possible. Please note on application.

No stakes allowed in Central Park due to electrical and irrigation system. Please bring weights.

HOSPITALITY

Complimentary coffee and refreshments will be provided for the artists each morning.

Assistance is available for set-up starting at noon on Friday and 8 am on Saturday.

Assistance is available for take-down starting at 4 pm on Sunday.

Booth sitters will be available for breaks each day.

Security provided on Friday and Saturday nights, but protection of artwork is the responsibility of artists.

Lunch options include vendors on the grounds and nearby restaurants.

Notify Information Booth if you need help.

AWARDS

Monetary awards and ribbons will be presented for Best of Show and various categories. Qualified judges will determine winners.

Number of places in each category is based on the number of artists in each category.

APPLICATION PROCESS

- All new artists applying for Arts in Central Park 2018 must be juried.
- Returning artists not juried in 2016 or 2017 must be juried.

Complete the Arts in Central Park 2018 application and send to:

Enclose a check with your application made payable to Decatur Area Arts Council.

- New artists and returning artists not juried in 2016 or 2017 - \$115 (\$100 booth fee, \$15 jury fee)
- Returning artists from 2017 - \$100 booth fee

If you need to be juried, submit five images that clearly represent all art to be exhibited and one of your booth.

- Images must be of work completed in the past two years
- Images must be in jpg, tif, or pdf format
- Images may be on a CD and sent with your application or images may be sent by email to arts4all@decatourarts.org

Artists not accepted will receive a refund check for the \$100 booth fee.

Applications must be postmarked by June 1, 2018.
